Lehigh County is the first County in the state of Pennsylvania that is taking out a bond to purchase the radios. The County will then set up a payment plan for the Municipalities. Phil is working on some grants for the Federal Government to help cover the cost for this radios. The radios run approximately \$7,000.00 to \$9,000.00 for each unit.

Lehigh County is the number one county in the state of Pennsylvania for acreage of farmland preserved versus how much acres of land we actually have. Percentage wise we are doing very well. It is very important to protect the farmlands as they are a valuable resource.

The community resource officer, Adrianna Calderon is still available for those who may need her assistance.

It is a tough time financially for many municipalities. Lehigh County did not have tax increases.

Phil will continue to stay on the National Organization of the County Executives of America. He will continue to represent nationally after his retirement.
